

STABIL LIMITED WARRANTY

STABIL Concrete Pavers, LLC's ("STABIL") interlocking concrete pavers meets the Requirements of ASTM C-936. STABIL warrants that its manufactured pavers and coping blocks are free from structural defects.

• "Structural Defects or Failure" is defined as a shortfall in the pavers and coping blocks to conform to STABIL's specifications, within industry allowable tolerances. Structural failure means pavers breaking in two under normal traffic and with proper base support. Fulfillment is limited to replacement of pavers only. This warranty does not apply to splitting, chipping, pitting, spalling or other breakage that may be caused by impact, abrasion or improper use

This express warranty is the sole warranty extended and completely replaces any and all other expressed or implied warranties including, but not limited to, the implied warranties of merchantability and fitness for a particular purpose. Stabil disclaims all express warranties not contained in this limited express warranty. STABIL specifically disclaims any liability for incidental or consequential damages. STABIL's warranty is limited to the structural integrity of the paver and **DOES NOT** include the following:

- Damage caused by misuse including negligence, physical, or chemical abuse
- Improper Installation
- Color variations between paver units including thick pavers to thin pavers.
- Efflorescence. Efflorescence in concrete pavers is a natural process. It is not grounds for rejection. All warranty claims must be reported immediately, failure to report any warranty claim of defect discovery will void this warranty.
- All STABIL products must be inspected prior to installation
- Installation of STABIL's products is deemed to be unconditional acceptance of such products.

This warranty is only valid if the material is installed under the guidelines of the <u>ICPI</u>, and <u>NCMA</u>
Specifications. Improper installation voids this warranty. This warranty is for residential applications only and does not apply to commercial applications

• Any questions or concerns on color variation must be made prior to installation (Paver and Coping blocks are subject to variations due to inherent variability in the raw materials and manufacturing process. Express technical specifications are not guarantees of minimum or maximum thresholds of performance.) A Stabil representative will investigate your claim within 7 business days. If the Stabil fails to meet the specifications, Stabil will replace the defective paver, or other hardscapes product at no charge. Color matching cannot be guaranteed. Stabil will not be responsible for any replacement labor, consequential damages or incidental damages.

Pavers and coping blocks are manufactured using sand and other naturally occurring materials. Because these products are not subject to manufacturing processes, quality warranties are limited to the specified representations in STABIL's product literature.

If a structural defect is discovered, STABIL will provide replacement product.

Buyer's remedy is limited to: Replacement of the defective product ONLY and does not include, among other items, the following:

- Freight
- Installation
- Removal costs
- Disposal costs
